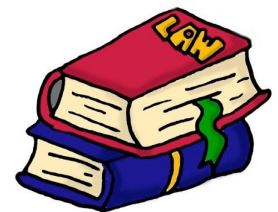

Student Senate Updates

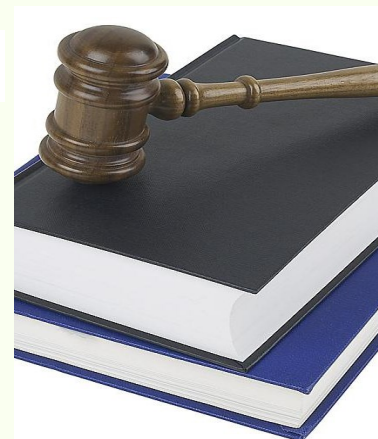

Anoka Crime Lab Tour

As a student in the Legal Studies Seminar and Internship class, I had the opportunity to visit the Anoka County Crime Lab on October 2, for our classroom field trip. The tour was approximately 90 minutes, but the abundance of information was immeasurable.

We were introduced to a DNA scientist who conducted the first half of our tour. She brought us to various parts of the Crime Lab including Evidence Intake, the DNA Labs, the Drug Chemistry Lab, the Toxicology Lab, as well as the department that processes latent prints. She explained how evidence is processed (and often times, eventually destroyed), how DNA is examined and can be separated,

the process of determining the purity of controlled substances, how toxicology labs can be processed, and the methods used to examine and compare latent prints.

The second half of our tour was led by a Sheriff's Deputy who brought us to the Crime Scene Garage and explained how they "process" vehicles that are involved in a crime. They usually receive one or two vehicles per week and they are able to process the vehicle in its entirety in their climate-controlled garage. "Processing" includes gathering DNA samples, fingerprinting, and removal of evidence, all of which is thoroughly documented for court records. She also explained blood-spatter

patterns and how the surface tension of blood, along with the amount of force, distance and angle, altogether can cause the blood to spatter in various ways.

Following the Crime Scene Garage, she showed us her own Crime Unit vehicle and all the items she takes to each scene, and then she brought us into another garage where S.W.A.T team vehicles are parked, along with the Dive Team and Water Patrol watercraft.

While this field trip is optional for Internship students (and required for practicum students), I highly recommend that you participate if you are able. It will be an opportunity and experience that you will never forget.
